# American Fisheries Society, North Central Division Rivers and Streams Technical Committee Annual Spring Meeting Minutes, March 14-15<sup>th</sup>, 2017 Rock Island Conservation Club, Milan Illinois

We had 43 people in attendance from state and federal agencies, organizations, and private consulting firms. This year's meeting theme was "Thinking outside the banks." Presentation and discussion topics included riparian corridors, watersheds, groundwater, meaningful restoration, and connecting with others outside our profession. There was a business meeting, numerous presentations and discussion, a stream table, and chapter reports.

Committee Chair, Aleshia Kenney, welcomed the committee and officially opened the meeting. Secretary/Treasurer, Megan Thul, presented the financial report.

**Treasurer's report:** On January 1, 2016 there was \$3,400.54 in the RSTC account. After the spring 2016 meeting was held, there was \$2,883.31 (-\$517.23). The group purchased a Bernie Schonhoff fish fryer (\$188) for a raffle item and provided three hotel rooms for students (\$335).

#### **Old Business**

Review of student participation: Student attendance is low despite efforts to encourage participation. Professional attendance at this meeting is partly due to low cost relative to other meetings. The group doesn't want to increase registration, if possible.
