Midwest Fish and Wildlife Conference Student Travel Grant

"Sander Award"

**Purpose:** To financially assist a student conducting research of interest to the Walleye Technical Committee of the North Central Division of the American Fisheries Society (WTC).

**Description:** A travel grant of \$200 from the WTC for a student to attend the Midwest Fish and Wildlife Conference. The Chair of the WTC will request matching funds from the student's AFS Chapter (total award up to \$400); however, there is no formal arrangement that guarantees matching funds.

**Eligibility Criteria:** The recipient of this award must be a student who is currently enrolled in a college or university degree program. Preference will be given to those involved in research of interest to the WTC.

**Documentation required:** An application letter from the student that includes: student's name, address, telephone number, educational institution, department, degree level, a short description of current research, reasons for wishing to attend the meeting (e.g., paper or poster presentation, pertinent paper session, sub-unit business, technical meetings), and reasons why financial assistance is needed.

**Selection Criteria:** The Operations Subcommittee of the WTC will evaluate applicants based on the following criteria:

- a. AFS involvement (reasons for attending the meeting).
- b. Relevance of research to the goals of the WTC.

**Frequency of Award:** The WTC will select one recipient each year.

**Deadline:** The deadline for receipt of completed applications is October 1, 2017. Please e-mail application materials to WTC Chair Jeff Koch at jeff.koch@ks.gov

## Announcing the Science Communication Announcing the NCD Knowledge Seeker Award

The NCD has developed the Knowledge Seeker Award to provide funding support (up to \$180) to undergraduate or graduate students seeking the opportunity to attend fisheries related trainings, workshops, or continuing education courses. Awards are granted three times a year for the purposes of helping students attend fisheries related courses at the Midwest Fish & Wildlife Conference, courses held online, or for other relevant trainings or workshops that require the student to travel or pay a registration fee that may preclude them from attendance. The total funds available for awards are split into triannual awards:

May 1st - Aug 31st (deadline to apply = Aug 17th) Sept 1st - Dec 31st (deadline to apply = Dec 17th) Jan 1st - Apr 30th (deadline to apply = Apr 16th)

Payment for accepted requests will be processed through the NCD Secretary/Treasurer in the form of a check following approval of the request. Students must provide to the Chair of the Continuing Education Committee prior to receiving the award. # **Standardized Assessment Symposium to be held at Midwest**

Building on the success of symposia held the past three years, the Reservoir Technical Committee will hold a symposium at the 78th Midwest Fish & Wildlife Conference entitled, "Development, Validation, and Application of Standardized Population Assessments in Inland Waters". This symposium, organized by state agency fisheries biologists in Kansas and Ohio, will detail standardized approaches used to monitor and manage sport fish populations. We seek additional presentations (both podium and poster) that describe (1) building novel standardized methods, (2) what the data collected tell managers about underlying sport fish dynamics, and (3) using standard, routine methods to understand changes due to management decisions, environmental changes, or other effects.
