American Fisheries Society, North Central Division Rivers and Stream Technical Committee Annual Spring Meeting Minutes, March 31-April 1, 2015 Rock Island Conservation Club, Milan Illinois

We had over 44 people in attendance from state and federal agencies, organizations, and private consulting firms. The theme for the meeting was small streams. In addition to the following business meeting results, we had numerous great presentations, and chapter reports.

Committee Chair, Matt Matheney, welcomed the committee, and officially opened the meeting. Secretary/Treasurer, Aleshia Kenney, presented the financials for the year. On January 1, 2014 we had \$3,036.97 in the budget. After the Spring Meeting 2014 and interest we had \$3,400.54 in the budget.

Old Business
